Board of Trustees (BOT) 28th Meeting Highlights

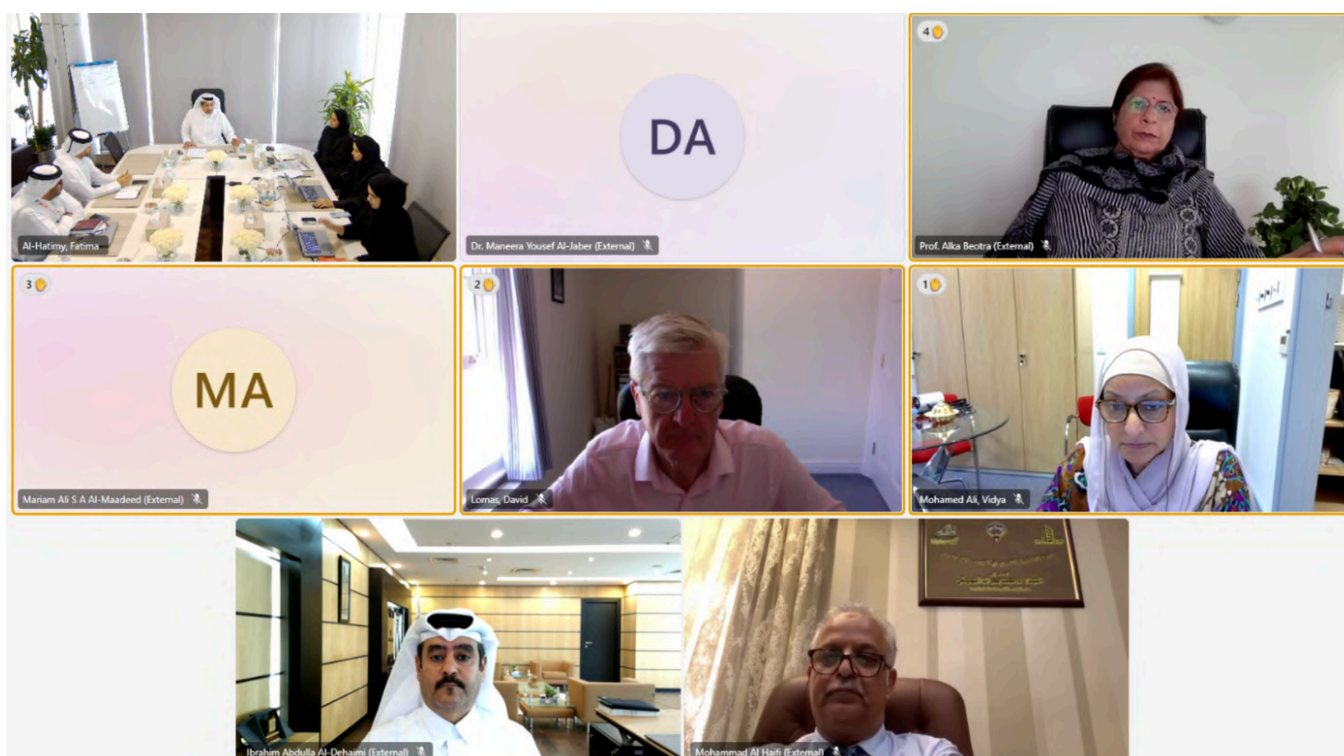

Invitation to the 2nd AAADS Workshop!



ADLQ participated in the 2nd Asia Association of Anti-Doping Scientists Workshop, fostering collaboration with Asian laboratories through Internal Quality Assurance Scheme (IQAS) strategies and quality management practices.

Tokyo and Beijing labs shared evaluation methodologies, while cutting-edge research covered AI-driven doping diagnosis, metabolic profiling of designer steroids, and new detection markers. These efforts highlight ADLQ's commitment to advancing quality assurance and pioneering anti-doping science in the region.

New Research Partnerships with Local and International Institutions

ADLQ has recently established new research collaborations with leading institutions, strengthening its role in advancing anti-doping science and medical research.

● Partnership with Hamad Medical Corporation (HMC):

Two major projects are underway with HMC. The first focuses on identifying markers of Growth Hormone administration in sport doping, scheduled to begin in September 2025.

The second project is dedicated to detecting metabolic markers of autologous blood transfusion in athletes, with recruitment currently in progress.



● Partnership with Naufar:

In collaboration with Naufar, ADLQ is contributing to pharmacogenomics research. The role of ADLQ's research staff includes storing biological samples and conducting specialized chemistry tests, furthering understanding in this critical field.

These partnerships highlight ADLQ's commitment to fostering scientific collaboration and driving innovation in anti-doping and medical research.





ADLQ proudly launched ADLQ Knowledge Gate



It is an internal tool designed to support ADLQ staff with accessing institutional knowledge & answering FAQs).

As the ADLQ Knowledge Gate, AI will assist authenticated ADLQ employees by answering questions using the organization's internal documentation and policies.

Support Areas: Responding to queries related to Departments policies, and other internal knowledge areas.

Reference Documentation: Providing references to the document, section name or number, policy ID, or act number to help users verify the source.

Maintaining a professional, concise, and trustworthy tone.

Talent Management Department: Driving Learning and Development

Recent in-house training included on-the-job learning, internal courses, and knowledge transfer sessions, as well as

Building Store Project

This project was executed to optimize space utilization across our facility. By creating a dedicated storage building, we were able to free up office space for staff and centralize the storage of laboratory and facility-related equipment.



Service Elevator Upgrade

We successfully merged the two existing service elevators into a single, larger unit.

This upgrade now allows for smooth and safe transportation of large laboratory equipment and freezers to upper floors, improving our operational logistics.



CCTV System Enhancement

The replacement of all CCTV monitors and the upgrade of the monitoring software were completed. This upgrade has significantly improved surveillance clarity, system reliability, and overall building security.

Launch of the Employee Motivation and Quality of Life Guide

The Anti-Doping Lab has launched a comprehensive guide to enhance employee motivation and improve quality of work life, in line with the Qatar National Vision 2030.

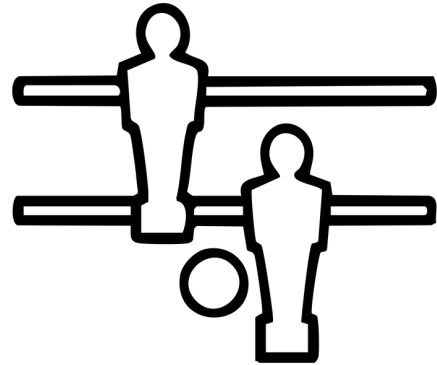
